

## ADDITIONS TO "A 2 PETER BIBLIOGRAPHY"

Certainly no one will disagree with the difficulty in locating articles from un-indexed periodical literature. The fine analytical works produced by Metzger<sup>1</sup> and Mattill<sup>2</sup> have become mainstays for research in Pauline literature, the gospels and Acts. Much work still needs to be done in compiling articles on Hebrews, the non-Pauline epistles and Revelation. The recent article by Snyder<sup>3</sup> has enhanced our access to a sizeable amount of material on 2 Peter which might otherwise go undetected. As a spin-off from a nine-year project on *An Index to English Periodical Literature on the Old Testament*<sup>4</sup> the following additions are offered for further study on 2 Peter.
